Dear Parent/Guardian:

For the 2011-2012 school year, your child is scheduled to attend Featherbed Lane Elementary School, a Title I school that has been identified as a Developing Comprehensive Needs school as identified by Differentiated Accountability. This determination is based on Maryland State Assessment (MSA) data by the Maryland State Department of Education. Because of this identification, Featherbed Lane Elementary School must offer *Public School Choice: Title I Transfer Option*. In an effort to assist you in making an informed decision regarding this option, the following questions and answers are provided:

## **Why has Featherbed Lane Elementary School been identified as a Developing Comprehensive Needs school?**

Under the *No Child Left Behind Act of 2001 (NCLB)*, schools must meet specific achievement targets in attendance, reading, and math. These annual improvement targets demonstrate if a school has made "Adequate Yearly Progress" (AYP). MSA data indicate that Featherbed Lane Elementary School did not make AYP for three or more consecutive years in the same subject area.

## **What is *Public School Choice: Title I Transfer Option*?**

*Public School Choice: Title I Transfer Option* allows families of students registered to attend Featherbed Lane Elementary School (Grades PreK-5) for 2011-2012 to transfer to a Baltimore County public school determined as eligible to receive students.

## **Which schools are eligible to receive students who access *Public School Choice: Title I Transfer Option*?**

The receiving schools for the 2011-2012 school year are Winand Elementary School and Woodbridge Elementary School. Annually, the system reviews its resources to make a determination as to which schools will be eligible to receive students. The receiving schools were chosen based on variables such as academic performance, bus ride time, and capacity.

## **Will your child have to transfer schools?**

No. The decision to transfer or to remain at the home school is entirely up to each parent/guardian. Parents/guardians should base their decision on what they think is best for their child. Many factors should be considered, including the school academic program, availability of extended-day activities, availability of extracurricular activities, etc.

## **How does Featherbed Lane Elementary School compare to the receiving schools?**

MSA data indicate that Featherbed Lane Elementary School did not meet AYP in the areas of reading and mathematics on the Maryland State Assessments (MSA). The chart below compares the percentage of

students who scored advanced, proficient, and basic on the 2011 MSA for Featherbed Lane Elementary School, the receiving schools, the Baltimore County Public Schools system, and state.

**What is the Featherbed Lane Elementary School staff doing to improve student achievement?**

The School Improvement Team at Featherbed Lane Elementary School is continuously analyzing school data to determine how to improve performance in reading and mathematics. Featherbed Lane Elementary School staff continuously monitors and evaluates student performance in order to improve the school’s academic program.

During the 2011-2012 school year, Featherbed Lane Elementary School will be implementing the following strategies to further improve student achievement:

- Provide Ongoing PD on how to implement 6+1 writing traits program;
- Ongoing PD on increasing rigor through scaffolding and small group differentiated math and reading instruction;
- Ongoing PD on PBIS positive behavior;
- Provide instructional strategies and resources for parents/guardians to use at home to reinforce and extend student learning; and
- Provide support to parent on how to use technology to support student achievement in reading and math.

**What is Baltimore County Public Schools doing to increase student achievement?**

The *Blueprint for Progress* provides clear direction for everyone involved in education in Baltimore County. The *Blueprint for Progress* is built on a foundation of clear standards, quality instruction, and individual accountability and is the basis for the Master Plan of the Baltimore County Public Schools. The Master Plan defines the actions the school system will take for continued improvement of achievement for all students. In addition, all students in BCPS receive instruction based on concepts in the State Curriculum. The Department of Professional Development and curriculum offices in collaboration with the Office of Title I provide professional development to assist teachers in developing the talents of students and provide each student access to a rigorous educational experience. Additionally, Featherbed Lane Elementary School receives technical assistance from the assistant superintendents’ office in the development and implementation of its School Improvement Plan.

**What can parents/guardians do to help Featherbed Lane Elementary School increase student achievement?**

Parents/guardians can assist the efforts of the school by making sure that their children come to school on time every day, ready to learn. In addition, parents can check that all homework assignments and school projects are completed on time. Parents are encouraged to participate in parent education activities, attend all parent-teacher conferences, and learn more about how to help their children at home and at school. Parents should tell teachers they want to hear from them as soon as problems occur so that they can work together to find solutions. **How can parents/guardians find out more information?**

Baltimore County Public Schools will be holding a meeting for parents/guardians at Featherbed Lane Elementary School on **Wednesday, August 24, 2011 from 6:30 – 7:30pm**. During this meeting, school administrators and central office staff will discuss:

- What identification as Developing Comprehensive Needs means;
- The reason that MSDE identified Featherbed Lane Elementary School as Developing Comprehensive Needs;
- What Featherbed Lane Elementary School staff are doing to address student needs;
- What parents/guardians can do to help address the academic issues that led to identification;
- The two decisions families have to either remain at Featherbed Lane Elementary School or request a transfer and;
- Information about the *Public School Choice: Title I Transfer Option* process and timeline.

**What is the due date for *Public School Choice: Title I Transfer Option* applications?**

*Public School Choice: Title I Transfer Option* applications **ARE DUE ON September 16, 2011**.

**How can parents/guardians obtain additional information if they cannot attend this meeting?**

A *Public School Choice: Title I Transfer Option* application is included with this letter and will be made available at Featherbed Lane Elementary School. A Featherbed Lane Elementary School staff member will be available to explain these documents.
