Proposed Revisions to Board of Education Policy 8311 Internal Board Policies: Operations: Meetings

Statement of issues or questions to be addressed by the proposed policy

The Ad Hoc Policy Committee continues its process of reviewing the Board's Internal operating policies. (8000 Series) The Committee's recommended revisions to Policy 8311, Meetings, will make it consistent with current practice. Additionally, the Policy codifies the Board's current, but long standing practice of using *Robert's Rules of Order* in the conduct of its board meetings. Lastly, the policy's legal references now include the state's Open Meetings Act.

INTERNAL BOARD POLICIES: Operations

Meetings: [Types]

- 1. Regular Meetings: Regularly scheduled meetings may be [of two kinds—business or educational. The latter type may be] held TO CONDUCT THE BUSINESS OF THE BOARD for the purpose of the review and evaluation of the school program, or the development and discussion of policy.
- [2. Special Meetings: Such a meeting may be called by the president of the Board or by four members collectively in the event that the president fails to act, or by the secretary-treasurer, upon due notice as specified by state bylaws. No business shall be transacted except that for which the meeting is called, unless by unanimous consent of Board members present.
- 3. Executive Meetings: Executive meetings or sessions of the Board shall be called at such time and place as is required for discussion of matters pertaining to land and site acquisition, personnel, and labor relations. No action may be taken in executive session; provision for statements of position or questions on points of order shall be made in open meetings.]
 - 2. THE BOARD OF EDUCATION'S MEETINGS SHALL BE CONDUCTED PURSUANT TO THE MOST RECENT EDITION OF <u>ROBERTS RULES OF ORDER</u>, UNLESS STATE LAW OR BOARD POLICY CONTROLS.
